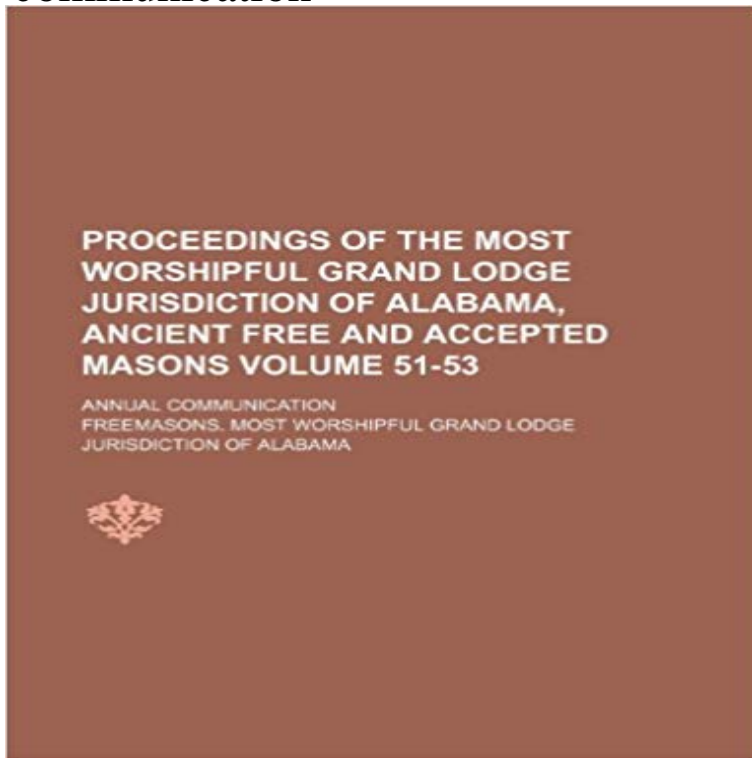

Not illustrated. 1872 Excerpt: ... we believe that dispensations (in the original meaning of the term), are now never granted; that Grand Masters give permission for a departure from the general law only when such power is expressly given to them in the constitution, and the use of the word dispensation, therefore, is scarcely accurate. The Grand Master is now generally regarded as a constitutional officer, with such powers as are given in the constitution, or are recognized in it as pertaining to his office; but we have seen no constitution which recognizes the old power of dispensation. We agree, therefore, with Brother Cobb, that the Grand Master has no power in such cases, unless it is expressly conferred by the constitution. Under Conclusion, Grand Masters Address, we find the following; The two great necessities of the institution to-day are--first, a careful guard over its portals, that no unworthy candidate shall obtain admission; and second, a high moral courage amongst its membership, that will not hesitate to discipline every fallen brother, who does not promise reformation.
