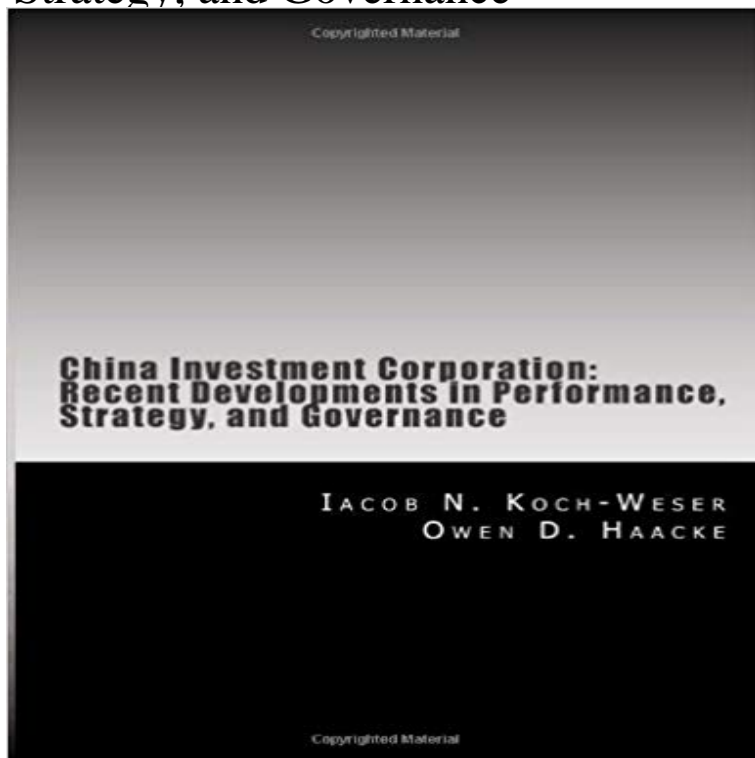


China Investment Corporation: Recent Developments in Performance, Strategy, and Governance



Over the past decade, sovereign wealth funds (SWFs) have proliferated and have increased their role in the international economy. China now has four SWFs and accounts for one-fifth of global SWF assets. China Investment Corp. (CIC), Chinas flagship SWF, has increased its assets from \$200 billion to an estimated \$500 billion in just five years as a result of funding and other support from the Chinese government. This report examines the operations and investment strategy of CIC. It also considers how Chinas SWFs are being regulated in the United States and internationally.
