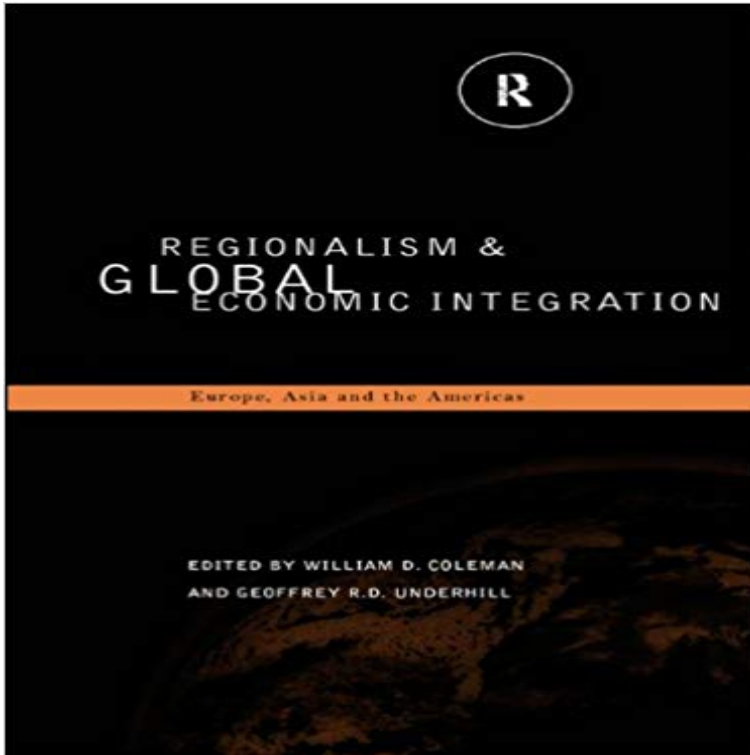


Regionalism and Global Economic Integration: Europe, Asia and the Americas
