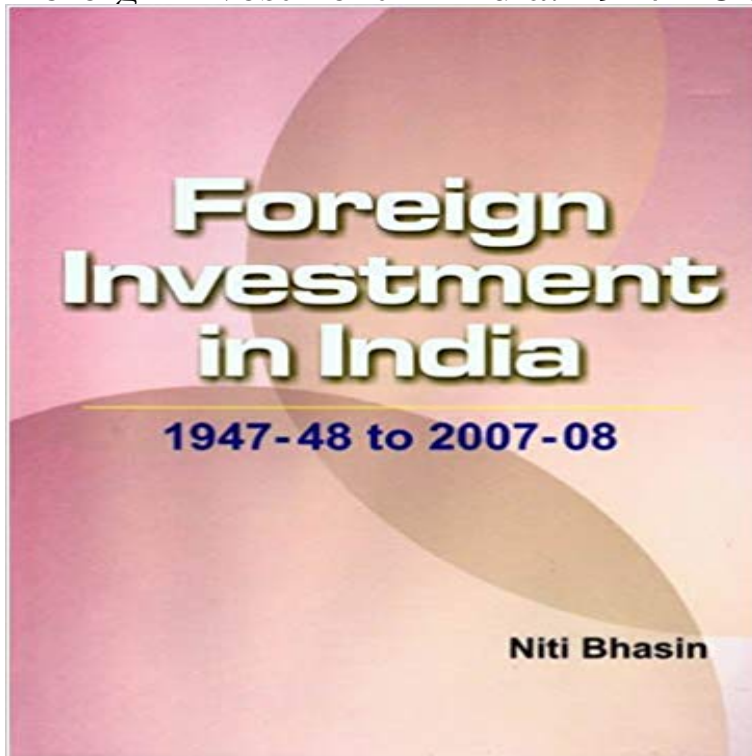


Foreign Investment in India: 1947-48 to 2007-08
