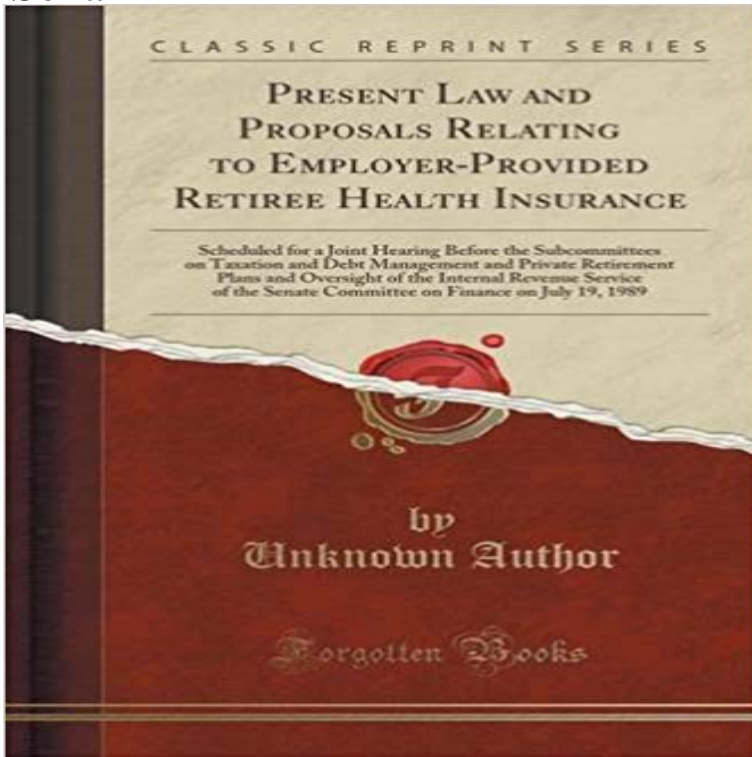

In addition, the Subcommittee will review what steps, if any, the Federal Government should take to improve the funding, availability, and security of retiree health benefits.
