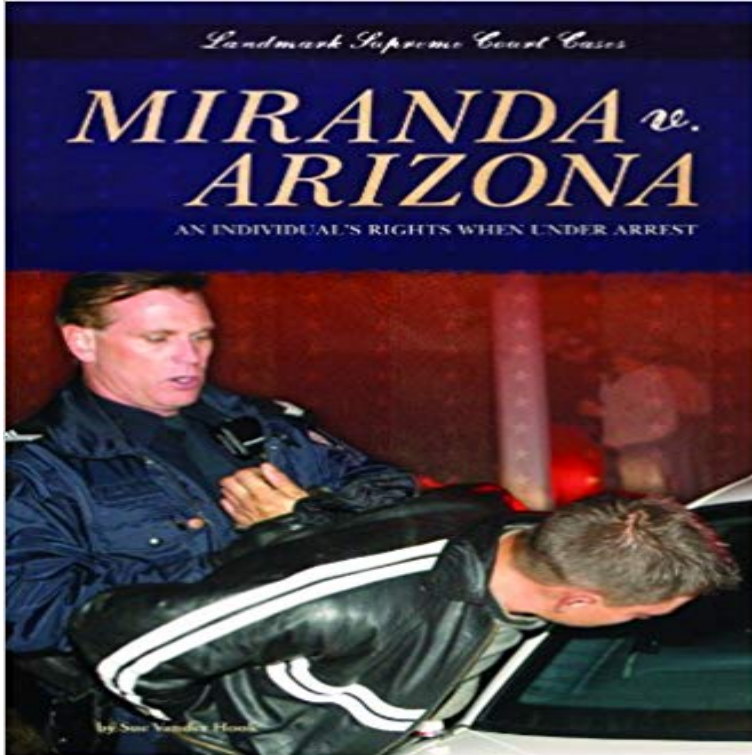


Miranda V. Arizona: An Individuals Rights When Under Arrest (Landmark Supreme Court Cases (Abdo))
