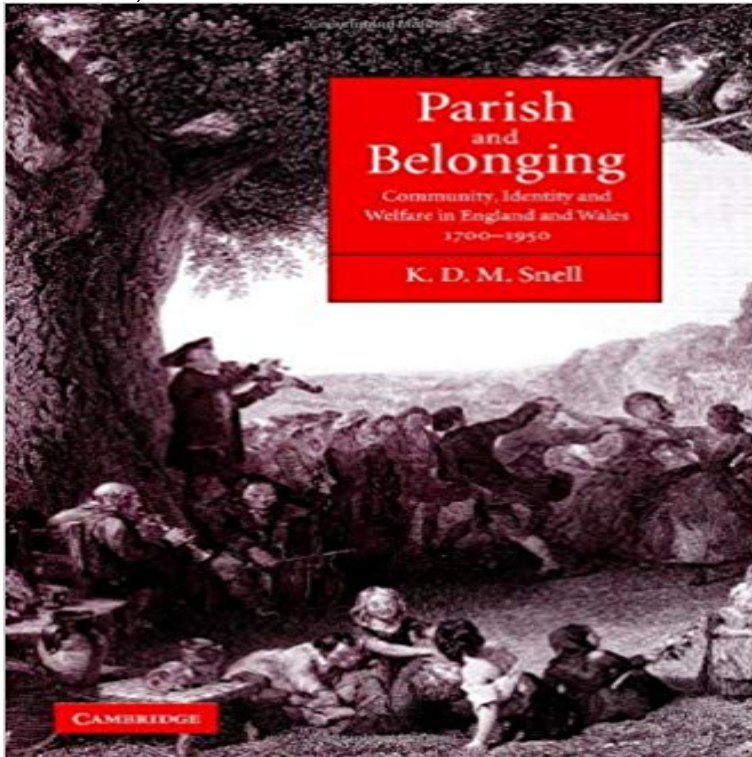


# Parish and Belonging: Community, Identity and Welfare in England and Wales, 1700-1950



What role did the parish play in peoples lives in England and Wales between 1700 and the mid-twentieth century? By comparison with globalisation and its dislocating effects, the book stresses how important parochial belonging once was. Professor Snell discusses themes such as settlement law and practice, marriage patterns, cultures of local xenophobia, the continuance of out-door relief in peoples own parishes under the new poor law, the many new parishes of the period and their effects upon peoples local attachments. The book highlights the continuing vitality of the parish as a unit in peoples lives, and the administration associated with it. It employs a variety of historical methods, and makes important contributions to the history of welfare, community identity and belonging. It is highly relevant to the modern themes of globalisation, de-localisation, and the decline of community, helping to set such changes and their consequences into local historical perspective.
