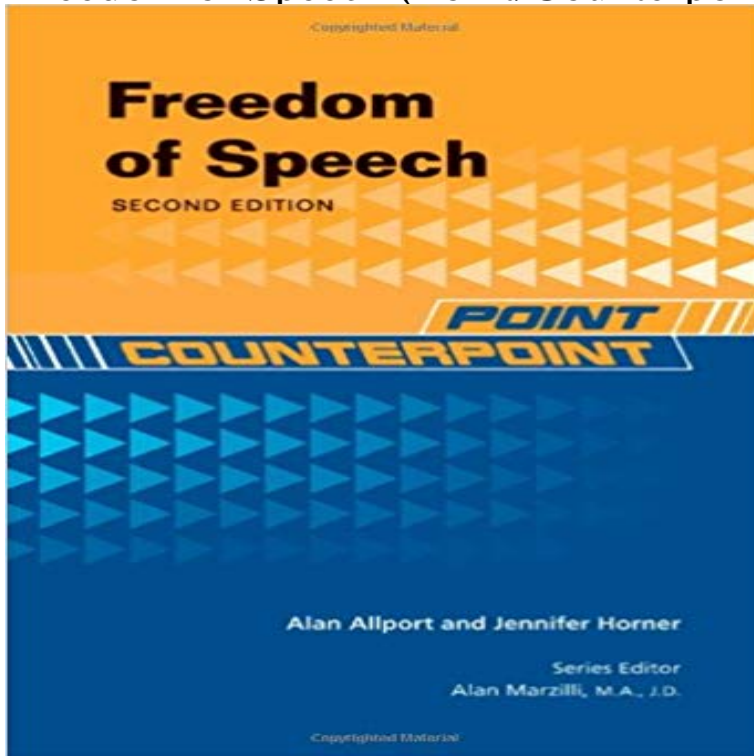


Freedom of Speech (Point/Counterpoint)
