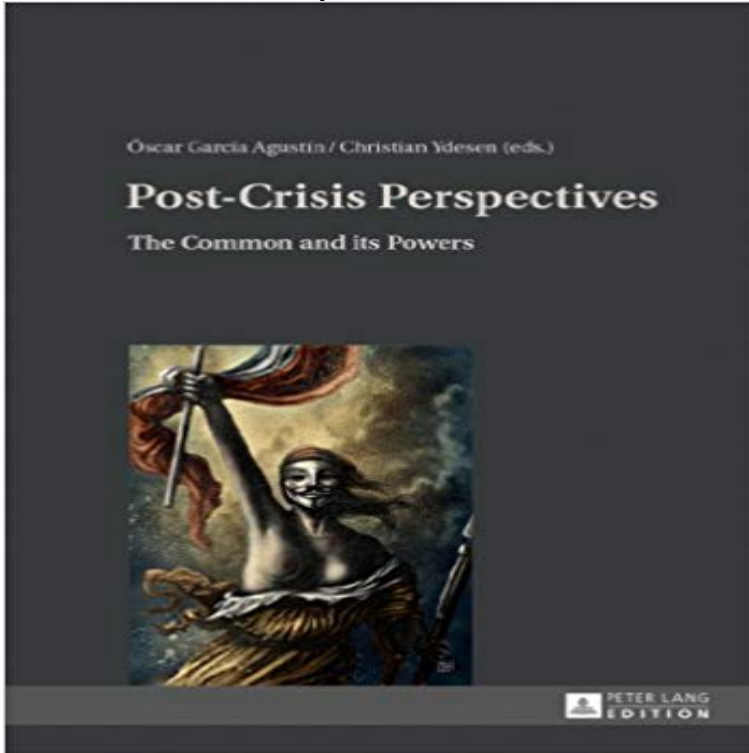


Post-Crisis Perspectives: The Common and its Powers
