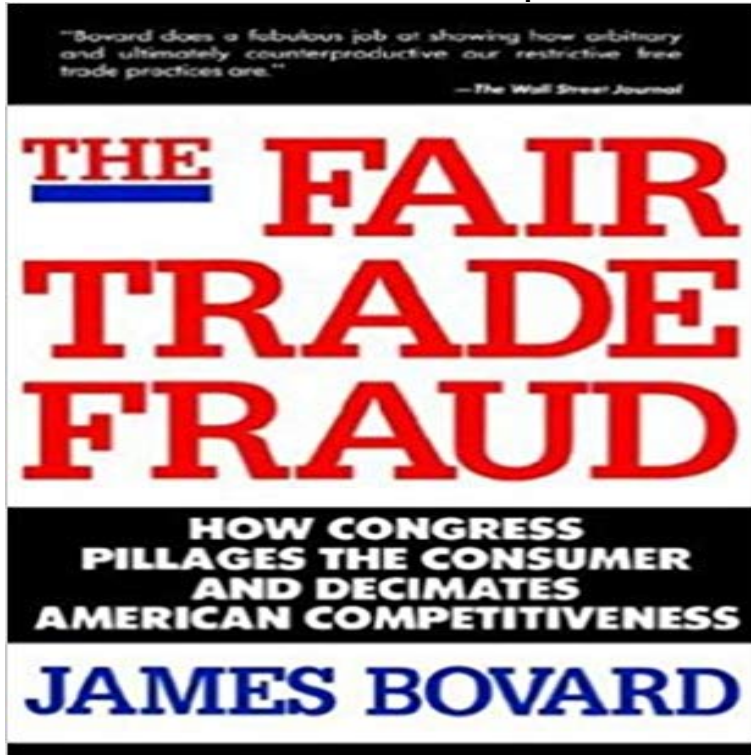


The Fair Trade Fraud: How Congress Pillages the Consumer and Decimates American Competitiveness
