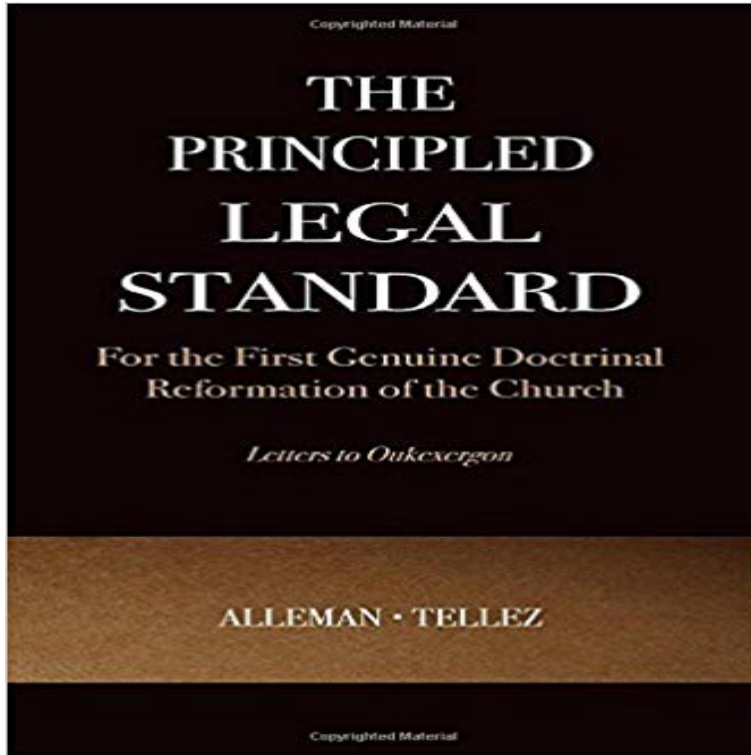


The Principled Legal Standard: for the First Genuine Doctrinal Reformation of the Church
