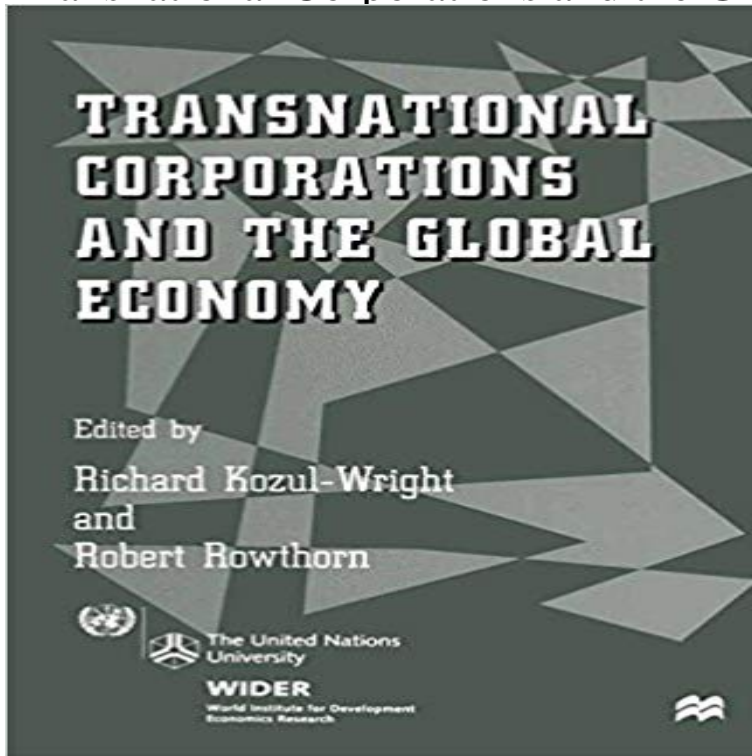


# Transnational Corporations and the Global Economy
