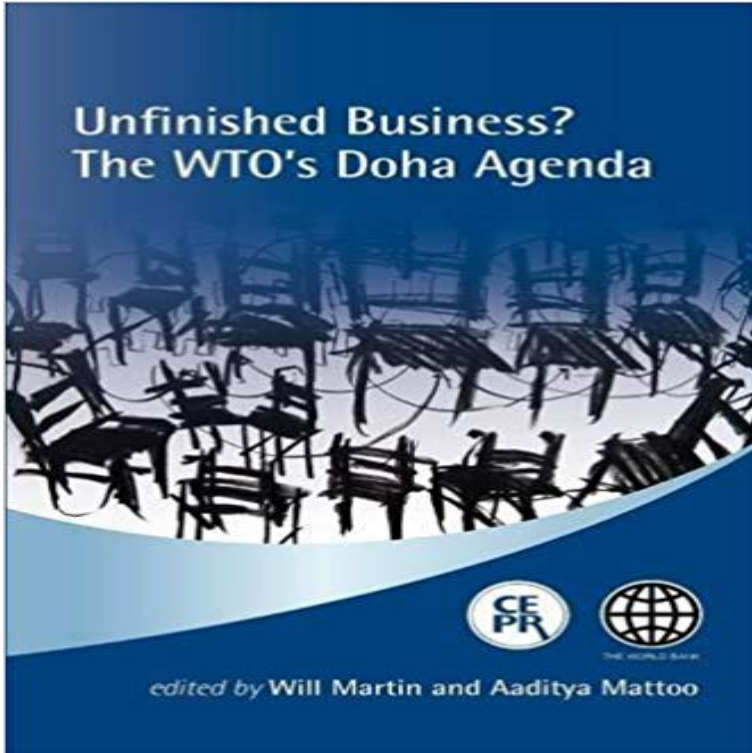


## Unfinished Business? the Wtos Doha Agenda
